<b>PRODUCTION PROCEDURES</b>	Antibody was affinity purified using an epitope specific to DDX19 immobilized on solid support.

The epitope recognized by A300-546A maps to a region between residues 400 and 450 of human DEAD (Asp-Glu-Ala-Asp) box polypeptide 19B using the numbering given in entry NP\_009173.1 (GeneID 11269). The epitope is highly conserved with DDX19A (GeneID 55308), but crossreactivity of the antibody with this homolog has not been assessed.

Immunoglobulin concentration was determined by extinction coefficient: absorbance at 280 nm of 1.4 equals 1.0 mg of IgG.

**APPLICATIONS** Centrifuge tube to remove product from lid. Optimal working dilutions should be determined experimentally by the investigator. Prepare working dilution immediately before use.

Western Blot 1:1,000 - 1:5,000

Immunoprecipitation 2 - 5 µg/mg lysate

**APPLICATION NOTES** Western blot of immunoprecipitates performed using Normal Pig Serum (Cat. No. S100-020), Goat anti-Rabbit Light Chain HRP Conjugate (Cat. No. A120-113P) and 4-20% SDS-PAGE (link to IP-western blot protocol in Additional Info section below).

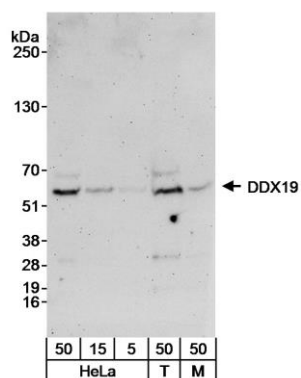
Western blot of lysates performed using standard western blot reagents and 4-20% SDS-PAGE.

*Samples:* Whole cell lysate from HeLa (5, 15 and 50 µg), HEK293T (T; 50 µg) and NIH 3T3 (M; 50 µg) cells. *Antibody:* Affinity purified rabbit anti-DDX19 antibody (Cat. No. A300-546A) used at 0.04 µg/ml for WB. *Detection:* Chemiluminescence with an exposure time of 3 minutes.
