

No. A300-780A-T) used for IP at 3 µg/mg lysate. ZWINT-1 was also immunoprecipitated by rabbit anti-ZWINT-1 antibody BL3453 (Cat. No. A300-781A). For blotting immunoprecipitated ZWINT-1, BL3453 was used at 1 µg/mg lysate. *Detection:* Chemiluminescence with an exposure time of 30 seconds.
