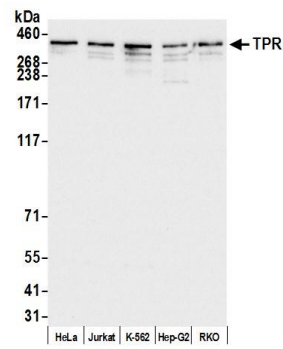

Western Blot 1:1000  Immunoprecipitation The antibody contained within A300-826A-T has been qualified for use in immunoprecipitation; however, we recommend using the alternative formulation of this antibody found as product A300-826A.
