<b>PRODUCTION PROCEDURES</b>	Antibody was affinity purified using an epitope specific to LEDGF/p75 immobilized on solid support.

The epitope recognized by A300-848A-T maps to a region between residue 480 and the C-terminus (residue 530) of human Lens Epithelium Derived Growth Factor/Transcriptional Coactivator p75 using the numbering given in entry NP\_150091.2 (GeneID 11168).

**APPLICATIONS** Centrifuge tube to remove product from lid. Optimal working dilutions should be determined experimentally by the investigator. Prepare working dilution immediately before use.

Western Blot 1:1000

Immunoprecipitation The antibody contained within A300-848A-T has been qualified for use in immunoprecipitation; however, we recommend using the alternative formulation of this antibody found as product A300-848A.

**APPLICATION NOTES** Western blot of immunoprecipitates performed using Normal Pig Serum (Cat. No. S100-020), Goat anti-Rabbit Light Chain HRP Conjugate (Cat. No. A120-113P) and 4-20% SDS-PAGE (link to IP-western blot protocol in Additional Info section below).

Western blot of lysates performed using standard western blot reagents and 4-20% SDS-PAGE.

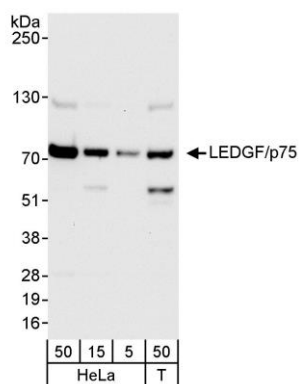

**Detection of human LEDGF/p75 by western blot.** *Samples:* Whole cell lysate from HeLa (5, 15, and 50  $\mu$ g) and HEK293T (T; 50  $\mu$ g) cells. *Antibody:* Affinity purified rabbit anti-LEDGF/p75 antibody A300-848A-T used at 1:1000. *Detection:* Chemiluminescence with an exposure time of 30 seconds.
