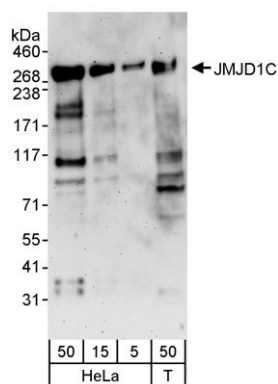

Detection of human JMJD1C by western blot. *Samples:* Whole cell lysate from HeLa (5, 15, and 50 µg) and HEK293T (T; 50 µg) cells. *Antibody:* Affinity purified rabbit anti-JMJD1C antibody A300-884A-T used at 1:1000. *Detection:* Chemiluminescence with an exposure time of 3 minutes.
