

Detection of human TRIM47/GOA by western blot of immunoprecipitates. *Samples:* Whole cell lysate (1 mg for IP, 20% of IP loaded) from HeLa cells. *Antibodies:* Affinity purified rabbit anti-TRIM47/GOA antibody A301–194A used for IP at 3 μ g/mg lysate. TRIM47/GOA was also immunoprecipitated by rabbit anti-TRIM47/GOA antibody A301–193A, which recognizes an upstream epitope. For blotting immunoprecipitated TRIM47/GOA, A301–193A was used at 1 μ g/ml. *Detection:* Chemiluminescence with an exposure time of 3 seconds.
