The epitope recognized by A700-006 maps to a region between residues 300 and the C-terminus (residue 346) of human Cyclin-Dependent Kinase 7 using the numbering given in Swiss-Prot entry P50613 (GeneID 1022).

**APPLICATIONS** Centrifuge tube to remove product from lid. Optimal working dilutions should be determined experimentally by the investigator. Prepare working dilution immediately before use.

A700-006CF is the carrier-free version of RMAB80-5D4, which is qualified for use in Western Blot, Immunoprecipitation, Immunohistochemistry, and/or Immunocytochemistry. The format of A700-006CF is designed for compatibility with the labeling of the antibody such as with fluorochromes, metal isotopes, oligonucleotides, and enzymes. Upon completion of labeling, the user must empirically define the assay dependent concentration for use.
