PRODUCTION PROCEDURES Recombinant antibody was purified from cell culture supernatan.

The epitope recognized by A700-007 maps to a region between residues 499 and 780 of human Protein Tyrosine Phosphatase, non-receptor type 12 using the numbering given in Swiss-Prot entry NP_002826.2 (GeneID 5782).

APPLICATIONS Centrifuge tube to remove product from lid. Optimal working dilutions should be determined experimentally by the investigator. Prepare working dilution immediately before use.

A700-007CF is the carrier-free version of RMAB5-2F8, which is qualified for use in Western Blot, Immunoprecipitation, Immunohistochemistry, and/or Immunocytochemistry. The format of A700-007CF is designed for compatibility with the labeling of the antibody such as with fluorochromes, metal isotopes, oligonucleotides, and enzymes. Upon completion of labeling, the user must empirically define the assay dependent concentration for use.
