**PRODUCTION PROCEDURES** Recombinant antibody was purified from cell culture supernatant.

Immunogen was a peptide representing a region between residue 600 and 650 of human Signal Transducer and Activator of Transcription 6 (STAT6) using the numbering given in entry NP\_001171549.1 (Gene ID 6778).

**APPLICATIONS** Centrifuge tube to remove product from lid. Optimal working dilutions should be determined experimentally by the investigator. Prepare working dilution immediately before use.

A700-147CF is the carrier-free version of A700-147, which is qualified for use in Western Blot, Immunoprecipitation, Immunohistochemistry, and/or Immunocytochemistry. The format of A700-147CF is designed for compatibility with the labeling of the antibody such as with fluorochromes, metal isotopes, oligonucleotides, and enzymes. Upon completion of labeling, the user must empirically define the assay dependent concentration for use.
