<b>APPLICATIONS</b>	Centrifuge tube to remove product from lid. Optimal working dilutions should be determined experimentally by the investigator. Prepare working dilution immediately before use.  A700-185CF is the carrier-free version of RMAB2075-1G2, which is qualified for use in Western Blot, Immunoprecipitation, Immunohistochemistry, and/or Immunocytochemistry. The format of A700-185CF is designed for compatibility with the labeling of the antibody such as with fluorochromes, metal isotopes, oligonucleotides, and enzymes. Upon completion of labeling, the user must empirically define the assay dependent concentration for use.
