PRODUCTIONAntiserum was cross adsorbed using bovine, chicken, horse, mouse, pig, rabbit and rat immunosorbents to remove cross reactive antibodies. The antibody to human IgG was

No antibody was detected against non-immunoglobulin serum proteins. Less than 1% cross reactivity to bovine, chicken, horse, mouse, pig, rabbit and rat IgG was detected. This antibody may cross react with IgG from other species.

experimentally by the investigator. Prepare working dilution immediately before use.
