PRODUCTION PROCEDURES	Antiserum was solid phase adsorbed to ensure subclass specificity. Antiserum was cross adsorbed using human and rat immunosorbents to remove cross reactive antibodies. The antibody to mouse IgG2c was isolated by affinity chromatography using antigen coupled to agarose beads and conjugated to fluorescein isothiocyanate (FITC).
	Antibody concentration was determined by extinction coefficient: absorbance at 280 nm of 1.4 equals 1.0 mg of IgG.
	By immunoelectrophoresis and ELISA this antibody reacts specifically with mouse IgG2c. Cross reactivity with immunoglobulins is less than 2%. No antibody was detected against non- immunoglobulin serum proteins. Less than 1% cross reactivity to human and rat IgG2c was detected. This antibody may cross react with IgG2c from other species.
APPLICATIONS	Centrifuge tube to remove product from lid. Optimal working dilutions should be determined experimentally by the investigator. Prepare working dilution immediately before use.
