PRODUCTION PROCEDURES	Purified normal human IgG is isolated using fractionation and DEAE chromatography. IgG with lambda chains was purified using affinity chromatography.

Protein concentration was determined by extinction coefficient: absorbance at 280 nm of 1.4 equals 1.0 mg of IgG.

By immunoelectrophoresis the IgG/lambda was shown to 1) react with antiserum specific for human IgG-Fc and lambda chains, 2) not react with antiserum specific for IgA, IgM or kappa chain and 3) produce a single precipitin arc with antiserum against human serum identical to that produced with anti-IgG.

By ELISA the IgG/lambda contains less than 0.1% of IgA, IgM and Kappa.

APPLICATIONS Centrifuge tube to remove product from lid. Optimal working dilutions should be determined experimentally by the investigator. Prepare working dilution immediately before use.

APPLICATION NOTES Used as a positive control in immunoassays.

Serum or plasma from donor has been tested and found negative for HIV-1 antigen, antibodies for HIV and HCV, and non-reactive for HBsAg, HIV-1 RNA, and HCV RNA. Not tested for Anti-HBc. HANDLE AS IF CAPABLE OF TRANSMITTING INFECTIOUS AGENTS.
