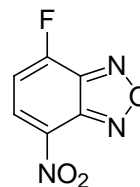

**STORAGE AND HANDLING:** Store at -20 °C and protect from light

**APPLICATION:** NBD fluoride is similar to NBD chloride (#90045) except that the former is much more reactive toward amines. Both reagents are nonfluorescent until they react with primary or secondary amines to produce a fluorescent product. NBD chloride and NBD fluoride have been extensively used as derivatizing reagents for chromatography analysis of amino acids and low molecular weight amines.
