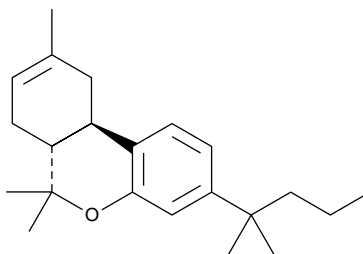

### Laboratory Procedures

For long term storage, we suggest that JWH 133 be stored as supplied at -20°C. It should be stable for at least one year. JWH 133 is supplied as a solution in methyl acetate. To change the solvent, simply evaporate the methyl acetate under a gentle stream of nitrogen and immediately add the solvent of choice. Solvents such as ethanol, DMSO, and dimethyl formamide purged with an inert gas can be used. The solubility of JWH 133 in these solvents is approximately 20, 10, and 30 mg/ml, respectively.

JWH 133 is sparingly soluble in aqueous solutions. To enhance aqueous solubility, dilute the organic solvent solution into aqueous buffers or isotonic saline. If performing biological experiments, ensure the residual amount of organic solvent is insignificant, since organic solvents may have physiological effects at low concentrations. We do not recommend storing the aqueous solution for more than one day.

JWH 133 is a synthetic cannabinoid (CB) that is over 200-fold selective for the peripheral CB<sub>2</sub> receptor (K<sub>i</sub> = 3.4 nM) over the central CB<sub>1</sub> receptor (K<sub>i</sub> = 677 nM).<sup>1</sup> It inhibits the growth of tumors in mice, increasing apoptosis and impairing angiogenesis.<sup>2,3</sup> JWH 133 also suppresses inflammation in experimental colitis and pancreatitis in mice as well as in *in vitro* models.<sup>4-6</sup>
