**Contents:** The vial contains 250 mM Tris-HCl, pH 8.0, containing 1.37 M NaCl, 27 mM KCl, and 10 mM MgCl<sub>2</sub>.  
**Stability:** ≥1 year at -20°C

### Laboratory Procedures

Prior to use in the HDAC Fluorometric Activity, HDAC1 Inhibitor Screening, or HDAC Cell-Based Activity Assay Kits (Item Nos. 10011563, 10011564, or 600150, respectively), dilute 5 ml of Assay Buffer concentrate with 45 ml of UltraPure water. This final Assay Buffer (25 mM Tris-HCl, pH 8.0, containing 137 mM NaCl, 2.7 mM KCl, and 1 mM MgCl<sub>2</sub>) is now ready for use. The diluted Assay Buffer is stable for six months at 4°C.
