## PTEN Blocking Peptide

PTEN dephosphorylates proteins and lipids such as AKT and phosphatidylinositol 3,4,5-triphosphate (PIP3) and therefore functions as a key regulatory enzyme in a central signal transduction pathway. PTEN is expressed in almost all tissues of the body as a 403 amino acid protein with an estimated molecular weight of 47 kDa, however the actual migration observed on western blot may vary among distinct samples.<sup>1</sup> PTEN interacts with many other proteins to regulate cell division and migration as well as promoting apoptosis when necessary.<sup>2</sup> Mutation of PTEN results in many human cancers including melanoma and prostate carcinoma.<sup>3,4</sup>

### Laboratory Procedures

This vial contains 200 µg peptide in 200 µl TBS, pH 7.4, containing 0.1% BSA and 0.02% sodium azide. The PTEN blocking peptide (human PTEN amino acids 254-270) can be used in conjunction with Cayman's PTEN Polyclonal Antibody (Item No. 10005059) to block protein-antibody complex formation during immunochemical analysis of PTEN.

Store this peptide solution at -20°C. It will be stable for at least two years. To block antibody/protein complex formation, the following procedure is recommended:

1. Mix the PTEN Polyclonal Antibody (Item No. 10005059) and blocking peptide together in a 1:1 (v/v) ratio in a microfuge tube. For example, mix 20 µl of antibody and 20 µl of peptide.\*
2. Incubate for one hour at room temperature with occasional mixing prior to further dilution and application of the mixture to the immunoblot.
3. Dilute the mixture to the final working antibody concentration and apply to the slide or membrane as usual.

\*This is a recommended mixture. The minimum amount of peptide needed for complete blocking has not been precisely determined and may vary depending on the sample being analyzed. The amount of peptide required may need to be increased if sufficient blocking does not occur.
