Laboratory Procedures

To prepare the buffer for use in the Nuclear Extraction Kit (Catalog No. 10009277), dilute reagents as outlined below. Some of the phosphatase and protease inhibitors lose activity shortly after dilution, therefore any remaining 1X hypotonic buffer should be discarded.
