## LDH Diaphorase

Item No. 10009318

### Laboratory Procedures

Reconstitute the contents of this vial with 150  $\mu$ l (96 well size) or 600  $\mu$ l (480 well size) of prepared Cell-Based Assay Buffer (Item No. 10009322) to generate a 100X stock solution of diaphorase. If the contents of the reconstituted enzyme will not be used all at once, it is recommended that aliquots be frozen at  $-20^{\circ}\text{C}$ . Freezing and thawing of the solution should be limited to a single time.

To prepare 10 ml of reaction solution, add 100  $\mu$ l of this stock solution, along with 100  $\mu$ l of 100X LDH NAD<sup>+</sup> (Item No. 10009319), 100  $\mu$ l of 100X LDH Lactic Acid (Item No. 10009320), and 100  $\mu$ l of 100X LDH INT (Item No. 10009328) to 9.6 ml of prepared Cell-Based Assay Buffer (Item No. 10009322).
