This vial contains 100 µl (96 well size), or 500 µl (480 well size) of a 100X NAD<sup>+</sup> Solution.

### Laboratory Procedures

To prepare 10 ml of reaction solution, add 100 µl of this stock solution, along with 100 µl of 100X LDH INT (Item No. 10009328), 100 µl of 100X LDH Lactic Acid (Item No. 10009320), and 100 µl of reconstituted 100X LDH Diaphorase Solution (Item No. 10009318) to 9.6 ml of prepared Cell-Based Assay Buffer (Item No. 10009322). The stock solution is stable for at least six months at 4°C.
