Contents

The vial contains 1 mg of Filipin III powder. The Cholesterol Detection Filipin III is good for one year when stored at -20°C.

Laboratory Procedures

To make a Filipin III stock solution, dissolve the whole vial of Filipin III in 200 µl of 100% ethanol. We highly recommend that you make small aliquots of Filipin III solution and store them at -80°C. Filipin III in solution is very unstable and its activity decrease significantly with repeat use.

To make a staining solution, dilute the Filipin III stock solution 1:100 in the Assay Buffer supplied in the Cholesterol Cell-Based Detection Assay Kit (Item No. 10009779). For example, add 100 µl of Filipin III stock solution to 9.9 ml of the Assay Buffer.
