Laboratory Procedures

For long term storage, we suggest that 17-phenoxy prostaglandin $F_{2\alpha}$ isopropyl ester (17-phenoxy $PGF_{2\alpha}$ isopropyl ester) be stored as supplied at -20°C. It should be stable for at least one year.

17-phenoxy PGF_{2 α} isopropyl ester is supplied as a solution in ethanol. To change the solvent, simply evaporate the ethanol under a gentle stream of nitrogen and immediately add the solvent of choice. Solvents such as DMSO and dimethyl formamide purged with an inert gas can be used. The solubility of 17-phenoxy PGF_{2 α} isopropyl ester in these solvents is approximately 100 mg/ml.

Further dilutions of the stock solution into aqueous buffers or isotonic saline should be made prior to performing biological experiments. Ensure that the residual amount of organic solvent is insignificant, since organic solvents may have physiological effects at low concentrations. If an organic solvent-free solution of 17-phenoxy PGF₂₀ isopropyl ester is needed, it can be prepared by evaporating the ethanol and directly dissolving the neat oil in aqueous buffers. The solubility of 17-phenoxy PGF $_{2a}$ isopropyl ester in PBS, pH 7.2, is approximately 1 mg/ml. We do not recommend storing the aqueous solution for more than one day.

The actions of many clinical F-series PGs, including those used for estrous synchronization and reduction of intraocular pressure (IOP), are mediated through the PGF_{2a} (FP) receptor. 1-3 17-phenoxy PGF_{2a} isopropyl ester is an analog of $PGF_{2\alpha}$ containing a 17-phenoxy group on the lower side chain and an isopropyl ester at the C-1 position. There are no published reports on the biological activity of 17-phenoxy PGF₂₀ isopropyl ester.
