Laboratory Procedures

The vial contains 20 ml of 10X protein-S-glutathione (PSSG) Assay Buffer. When stored as supplied the buffer is stable for two years at room temperature. Prior to use in the assay, bring to room temperature and dilute the contents of the vial to 200 ml with purified water. This final Assay Buffer (200 ml) is used in the S-Glutathionylated Protein Detection Kit (Catalog No. 10010721). The diluted Assay Buffer is stable for six months at room temperature.
