## Glycerol Enzyme Mixture

Item No. 10010962

**Contents:** This vial contains a lyophilized enzyme mixture

**Stability:** ≥1 year at -20°C

### Laboratory Procedures

Prior to performing the Glycerol Assay (Item No. 10010755) reconstitute the enzyme mixture with 1 ml of HPC-grade water. Transfer the reconstituted solution to a 15 ml centrifuge tube wrapped in aluminum foil. Add 14 ml of diluted Sodium Phosphate Assay Buffer (Item No. 700003) to the reconstituted solution and mix by inversion. The solution is now ready to use in the assay. If the entire solution is not used at one time, the solution can be stored at 4°C. *NOTE: Do not freeze!* The solution is stable for one month stored at 4°C; a slight pink discoloration may occur but will have no affect on the assay performance.

For laboratory research use only. This reagent is not for human or veterinary use. This product has been tested and formulated to work exclusively with the Glycerol Colorimetric Assay Kit from Cayman Chemical (Item No. 10010755). This product may not perform as described if used with other assay reagents or protocols.
