Laboratory Procedures

Thaw the enzyme on ice. Prior to use in the SIRT1 Direct Fluorescent Screening Assay Kit (Catalog No. 10010401), add 300 μ l of diluted SIRT1 Direct Assay Buffer (10X) (Item No. 10010993). The diluted enzyme is stable for four hours at 4°C . One vial of enzyme is enough SIRT1 to assay 80 wells.
