### Laboratory Procedures

Thaw the enzyme on ice. Dilute 20 µl of SIRT1 with 780 µl of diluted SIRT1 FRET Assay Buffer (10X) (Item No. 10011080) prior to use in the SIRT1 FRET-Based Screening Assay Kit (Item No. 10010991). The diluted enzyme is stable for four hours at 4°C.
