Thaw the developer on ice. Dilute 15 µl of developer with 735 µl of diluted SIRT1 FRET Assay Buffer (10X) (Item No. 10011080) prior to performing the SIRT1 FRET-Based Screening Assay Kit (Item No. 10010991). The diluted developer is stable for four hours at 4°C.
