Laboratory Procedures

Thaw the enzyme on ice. Prior to use in the SIRT3 Direct Fluorescent Screening Assay Kit (Item No. 10011566), add 200 µl of diluted SIRT3 Direct Assay Buffer (10X) (Item No. 10012540). The diluted enzyme is stable for four hours at 4°C. One vial of enzyme is enough SIRT3 to assay 50 wells.
