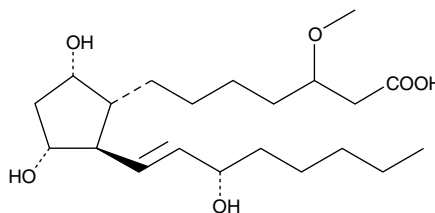

3-methoxy Prostaglandin F_{1α}

Laboratory Procedures

3-methoxy Prostaglandin F_{1α} (3-methoxy PGF_{1α}) is a novel analog of PGF_{1α} with a methoxy group in the 3-position of the upper side chain. For long term storage, we suggest that 3-methoxy PGF_{1α} be stored as supplied at -20°C. It will be stable for at least one year.

3-methoxy PGF_{1α} is supplied as a solution in methyl acetate. To change the solvent, simply evaporate the methyl acetate under a gentle stream of nitrogen and immediately add the solvent of choice. Solvents such as ethanol, DMSO, and dimethyl formamide purged with an inert gas can be used. The solubility of 3-methoxy PGF_{1α} in these solvents is approximately 23 mg/ml. 3-methoxy PGF_{1α} is stable for at least six months in these solvents if stored at -20°C.

Further dilutions of the stock solution into aqueous buffers or isotonic saline should be made prior to performing biological experiments. Ensure that the residual amount of organic solvent is insignificant, since organic solvents may have physiological effects at low concentrations. If an organic solvent-free solution of 3-methoxy PGF_{1α} is needed, it can be prepared by evaporating the methyl acetate and directly dissolving the neat oil in aqueous buffers. The solubility of 3-methoxy PGF_{1α} in PBS (pH 7.2) is approximately 16 mg/ml. We do not recommend storing the aqueous solution for more than one day.

There are no published reports describing the pharmacology of 3-methoxy PGF_{1α} at this time.
