Laboratory Procedures

For long term storage, we suggest that 11-deoxy Prostaglandin $F_{1\beta}$ (11-d-PGF $_{1\beta}$) be stored as supplied at -20°C. It will be stable for at least two years.

11-d-PGF₁₈ is sparingly soluble in water but freely soluble in organic solvents such as ethanol, methanol, acetone, acetonitrile, or DMSO. The solubility of 11-d-PGF $_{1\beta}$ in these solvents is approximately 10 mg/ml. 11-d-PGF $_{1\beta}$ is stable for at least six months in these solvents if stored at -20°C. Further dilutions of the stock solution into aqueous buffers or isotonic saline should be made prior to performing any biological experiments. Ensure that the residual amount of organic solvent is insignificant, since organic solvents may have physiological effects at low concentrations. We do not recommend storing the aqueous solution for more than one day.

Organic solvent-free aqueous solutions of 11-d-PGF $_{1\beta}$ can be prepared by directly dissolving the crystalline compound in basic solutions. The solubility of 11-d-PGF $_{1\beta}$ in 0.01 M aqueous Na $_2$ CO $_3$ is approximately 6 mg/ml. Again, we do not recommend storing the aqueous solutions for more than one day.
