#### **Laboratory Procedures**

For long term storage, we suggest that Prostaglandin  $F_{2\alpha}$  1,11-lactone (PGF<sub>2\alpha</sub> 1,11-lactone) be stored as supplied at -20°C. It will be stable for at least one year.

PGF<sub>20</sub>, 1,11-lactone is supplied as a solution in methyl acetate. To change the solvent, simply evaporate the methyl acetate under a gentle stream of nitrogen and immediately add the solvent of choice. Solvents such as DMSO, ethanol, and dimethyl formamide purged with an inert gas can be used. The solubility of  $PGF_{2\alpha}$  1,11-lactone in these solvents is approximately 10 mg/ml.  $PGF_{2\alpha}$  1,11-lactone is stable for at least six months in these solvents if stored at -20°C.

PGF<sub>20</sub> 1,11-lactone is sparingly soluble in aqueous solutions (<50 µg/ml). Further dilutions of the organic stock solution into aqueous buffers or isotonic saline should be made prior to performing biological experiments. Ensure that the residual amount of organic solvent is insignificant, since organic solvents may have physiological effects at low concentrations. We do not recommend storing the aqueous solution for more than one day.

 $PGF_{2\alpha}$  1,11-lactone is a lipid-soluble internal ester of  $PGF_{2\alpha}$ . Hydrolysis of the lactone by plasma esterases readily produces free  $PGF_{2\alpha}$  in rats and monkeys, but not in humans. PGF<sub>2\alpha</sub>,11-lactone is active as an antifertility agent with greatly reduced vasoactivity compared to PGF<sub>20</sub>.1
