#### **Laboratory Procedures**

For long term storage, we suggest that 5-trans Prostaglandin  $F_{2\alpha}$  (tromethamine salt) (5-trans PGF $_{2\alpha}$ (tromethamine salt)) be stored as supplied at -20°C. It should be stable for at least two years.

5-trans  $PGF_{2\alpha}$  (tromethamine salt) is supplied as a crystalline solid. A stock solution may be made by dissolving the  $\overline{5}$ -trans PGF<sub>2a</sub> (tromethamine salt) in an organic solvent. 5-trans PGF<sub>2a</sub> (tromethamine salt) is soluble in organic solvents such as ethanol, DMSO, and dimethyl formamide. The solubility of 5-trans PGF<sub>20</sub> (tromethamine salt) in these solvents is approximately 50 mg/ml. 5-trans PGF<sub>2n</sub> (tromethamine salt) will be stable for at least six months in these solvents if stored at -20°C.

Further dilutions of the stock solution into aqueous buffers or isotonic saline should be made prior to performing biological experiments. Ensure that the residual amount of organic solvent is insignificant, since organic solvents may have physiological effects at low concentrations. Organic solvent-free aqueous solutions of 5-trans  $PGF_{2\alpha}$  (tromethamine salt) can be prepared by directly dissolving the crystalline compound in aqueous buffers. The solubility of 5-trans PGF<sub>2a</sub>(tromethamine salt) in PBS is approximately 25 mg/ml compared to 10 mg/ml for 5-trans PGF $_{2a}$ . We do not recommend storing the aqueous solution for more than one day.

### Description

5-trans  $PGF_{2\alpha}$  is the more thermodynamically stable C-5 olefin isomer of  $PGF_{2\alpha}$  and is a common impurity in commercial lots of PGF<sub>2n</sub>. There are no published reports on the biological activity of this compound.
