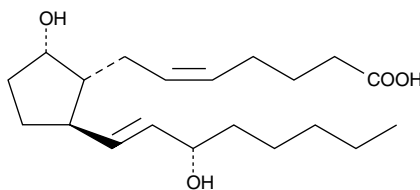

11-deoxy Prostaglandin F_{2α}

Laboratory Procedures

For long term storage, we suggest that 11-deoxy Prostaglandin F_{2α} (11-deoxy PGF_{2α}) be stored as supplied at -20°C. It should be stable for at least one year.

11-deoxy PGF_{2α} is supplied as a solution in methyl acetate. To change the solvent, simply evaporate the methyl acetate under a gentle stream of nitrogen and immediately add the solvent of choice. Solvents such as ethanol, DMSO or dimethyl formamide purged with an inert gas can be used. The solubility of 11-deoxy PGF_{2α} in these solvents is approximately 100 mg/ml.

Further dilutions of the stock solution into aqueous buffers or isotonic saline should be made prior to performing biological experiments. Ensure that the residual amount of organic solvent is insignificant, since organic solvents may have physiological effects at low concentrations. If an organic solvent-free solution of 11-deoxy PGF_{2α} is needed, it can be prepared by evaporating the methyl acetate and directly dissolving the neat oil in aqueous buffers. The solubility of 11-deoxy PGF_{2α} in PBS, pH 7.2, is approximately 10 mg/ml.

For greater aqueous solubility, 11-deoxy PGF_{2α} can be directly dissolved in 10 M Na₂CO₃ (solubility of 6 mg/ml). We recommend storing the aqueous solutions of 11-deoxy PGF_{2α} on ice and using within 12 hours.

11-deoxy PGF_{2α} is a synthetic analog of PGF_{2α}. It is a more potent agonist than PGF_{2α} at inducing smooth muscle contractions of rabbit aorta, dog saphenous vein, and guinea pig trachea.¹ It is approximately 20% less potent than U-46619.¹
