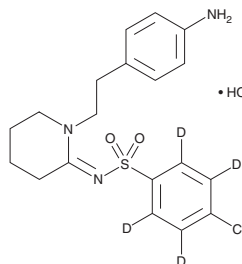

W-19-d₄ (hydrochloride) (Item No. 19487) is an analytical reference material intended for use as an internal standard for the quantification of W-19 (Item No. 19484) by GC- or LC-MS. The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated versus unlabeled).

W-19 is categorized as an analgesic.¹ It is a nitro-reduction metabolite of W-18 (Item Nos. 15480 | 19483). This product is intended for research and forensic applications.
