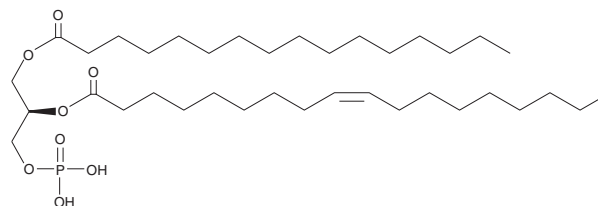

Laboratory Procedures

1-Palmitoyl-2-oleoyl-*sn*-glycero-3-PA (POPA) is supplied as a solution in chloroform. POPA is soluble in the organic solvent chloroform at a concentration of approximately 5 mg/ml.

Description

POPA is a phospholipid containing saturated palmitic acid (16:0) and monounsaturated oleic acid (18:1) inserted at the *sn*-1 and *sn*-2 positions, respectively. It can be used in the generation of micelles, liposomes, and other types of artificial membranes.¹
