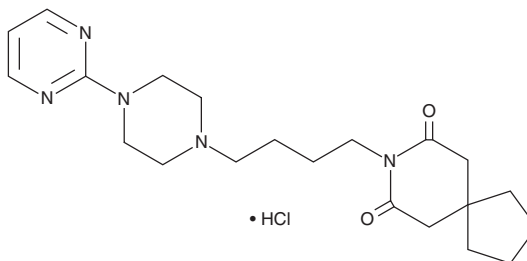

Description

Buspirone (hydrochloride) (Item No. 22028) is an analytical reference standard that is categorized as an anxiolytic.¹ It modulates serotonin and dopamine receptors, undergoes rapid first-pass metabolism, and is metabolized to phenylpiperazine (Item No. 11203), which has high affinity for α-adrenergic receptors.² This product is intended for research and forensic applications.
