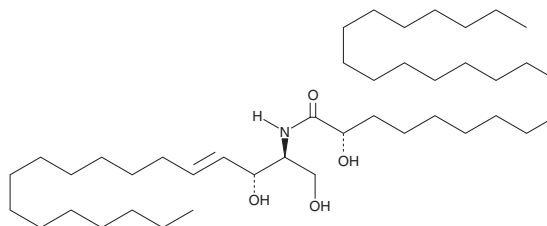

### Laboratory Procedures

C24 (2'(S)-hydroxy) Ceramide (d18:1/24:0) is supplied as a solid. A stock solution may be made by dissolving the C24 (2'(S)-hydroxy) ceramide (d18:1/24:0) in the solvent of choice, which should be purged with an inert gas. C24 (2'(S)-hydroxy) Ceramide (d18:1/24:0) is soluble in a 80:20 solution of chloroform:methanol. C24 (2'(S)-hydroxy) Ceramide (d18:1/24:0) is also soluble in ethanol (warmed).

### Description

C24 (2'(S)-hydroxy) Ceramide is a ceramide and an isomer of C24 (2'(R)-hydroxy) ceramide (Item No. 22527) that has been found in *D. lenticellatum*.<sup>1</sup>
