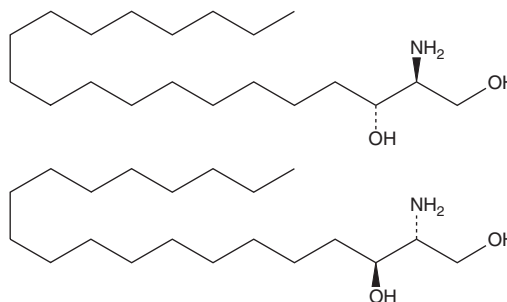

DL-erythro Sphinganine (d20:0) is a mixture of naturally occurring sphinganine (d20:0) (Item No. 22509) and synthetic L-erythro sphinganine (d20:0).
