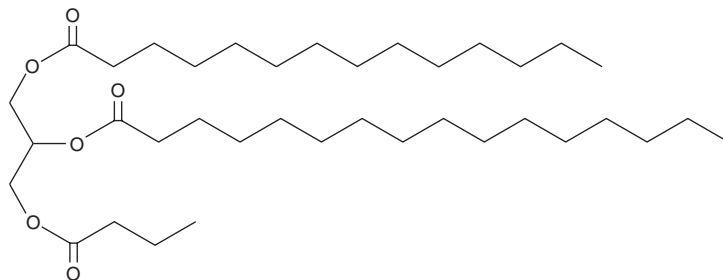

Laboratory Procedures

1-Myristoyl-2-palmitoyl-3-butyryl-*rac*-glycerol is supplied as a solid. A stock solution may be made by dissolving the 1-myristoyl-2-palmitoyl-3-butyryl-*rac*-glycerol in the solvent of choice, which should be purged with an inert gas. 1-Myristoyl-2-palmitoyl-3-butyryl-*rac*-glycerol is slightly soluble in methanol and chloroform.

Description

1-Myristoyl-2-palmitoyl-3-butyryl-*rac*-glycerol is a triacylglycerol containing myristic acid (Item No. 13351), palmitic acid (Item No. 10006627), and butyric acid (Item No. 13121) at the *sn*-1, *sn*-2, and *sn*-3 positions, respectively. It has been detected in human breast milk.¹
