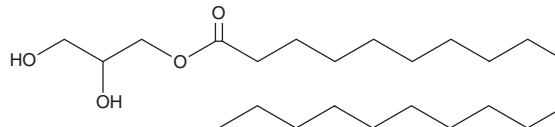

Laboratory Procedures

1-Arachidoyl-*rac*-glycerol is supplied as a solid. A stock solution may be made by dissolving the 1-arachidoyl-*rac*-glycerol in the solvent of choice, which should be purged with an inert gas. 1-Arachidoyl-*rac*-glycerol is soluble in organic solvents such as ethanol and dimethyl formamide. The solubility of 1-arachidoyl-*rac*-glycerol in these solvents is approximately 15 mg/ml.

Description

1-Arachidoyl-*rac*-glycerol is a monoacylglycerol that contains arachidic acid (Item Nos. 9000339 | 21906) at the *sn*-1 position. It has been found in pork muscle.¹
