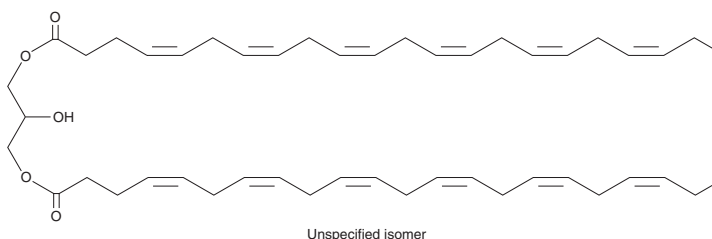

Laboratory Procedures

Didocosaehaenoin is supplied as a liquid. A stock solution may be made by dissolving the didocosaehaenoin in the solvent of choice, which should be purged with an inert gas. Didocosaehaenoin is soluble in organic solvents such as ethanol and dimethyl formamide. The solubility of didocosaehaenoin in these solvents is approximately 10 mg/ml. Didocosaehaenoin is also slightly soluble in chloroform.

Didocosaehaenoin is sparingly soluble in aqueous buffers. For maximum solubility in aqueous buffers, didocosaehaenoin should first be dissolved in ethanol and then diluted with the aqueous buffer of choice. Didocosaehaenoin has a solubility of approximately 0.5 mg/ml in a 1:1 solution of ethanol:PBS (pH 7.2) using this method. We do not recommend storing the aqueous solution for more than one day.

Description

Didocosaehaenoin is a diacylglycerol that contains docosahexaenoic acid (DHA; Item No. 90310) at two positions.
