

#### **Laboratory Procedures**

Distearin is supplied as a crystalline solid. A stock solution may be made by dissolving the distearin in the solvent of choice, which should be purged with an inert gas. Distearin is soluble in organic solvents such as ethanol, DMSO, and dimethyl formamide. The solubility of distearin in these solvents is approximately 0.25, 30, and 20 mg/ml, respectively.

Further dilutions of the stock solution into aqueous buffers or isotonic saline should be made prior to performing biological experiments. Ensure that the residual amount of organic solvent is insignificant, since organic solvents may have physiological effects at low concentrations. Organic solvent-free aqueous solutions of distearin can be prepared by directly dissolving the crystalline solid in aqueous buffers. The solubility of distearin in PBS, pH 7.2, is approximately 0.70 mg/ml. We do not recommend storing the aqueous solution for more than one day.

#### Description

Distearin is a diacylglycerol that contains stearic acid (Item No. 10011298) at two positions.
