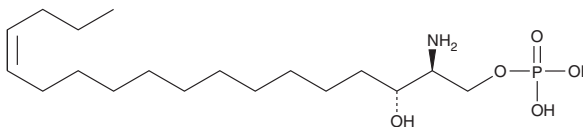

Laboratory Procedures

Sphingosine-1-phosphate (d18:1(14Z)) is supplied as a crystalline solid. Aqueous solutions of sphingosine-1-phosphate (d18:1(14Z)) can be prepared by directly dissolving the crystalline solid in aqueous buffers. The solubility of sphingosine-1-phosphate (d18:1(14Z)) in 0.3 M sodium hydroxide is approximately 4 mg/ml. We do not recommend storing the aqueous solution for more than one day.

Description

Sphingosine-1-phosphate (d18:1(14Z)) is an atypical sphingolipid that contains a *cis* double bond at the 14-15 position rather than a *trans* double bond at the 4-5 position as in sphingosine-1-phosphate (d18:1) (Item No. 62570).
