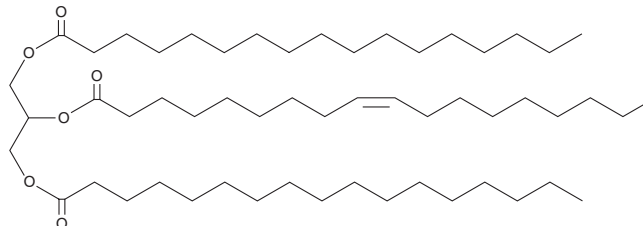

1,3-Diheptadecanoyl-2-oleoyl glycerol is supplied as a solid. A stock solution may be made by dissolving the 1,3-diheptadecanoyl-2-oleoyl glycerol in the solvent of choice, which should be purged with an inert gas. 1,3-Diheptadecanoyl-2-oleoyl glycerol is slightly soluble in chloroform and methanol.

Description

1,3-Diheptadecanoyl-2-oleoyl glycerol is a triacylglycerol that contains heptadecanoic acid (Item No. 19722) at the *sn*-1 and *sn*-3 positions and oleic acid (Item Nos. 90260 | 24659) at the *sn*-2 position.
