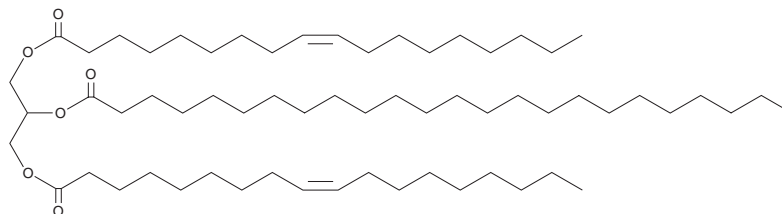

1,3-Dioleoyl-2-lignoceroyl glycerol is supplied as a liquid. A stock solution may be made by dissolving the 1,3-dioleoyl-2-lignoceroyl glycerol in the solvent of choice, which should be purged with an inert gas. 1,3-Dioleoyl-2-lignoceroyl glycerol is slightly soluble in methanol and chloroform.

Description

1,3-Dioleoyl-2-lignoceroyl glycerol is a triacylglycerol that contains oleic acid (Item Nos. 90260 | 24659) at the *sn*-1 and *sn*-3 positions and lignoceric acid (Item No. 13353) at the *sn*-2 position.
