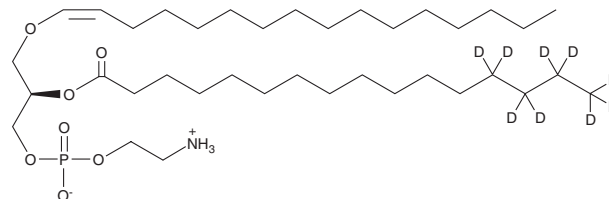

### Laboratory Procedures

1-1(Z)-Hexadecenyl-2-palmitoyl-d<sub>9</sub>-sn-glycero-3-PE is intended for use as an internal standard for the quantification of 1-1(Z)-hexadecenyl-2-palmitoyl-sn-glycero-3-PE (Item No. 28349) by GC- or LC-MS. The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated versus unlabeled).

1-1(Z)-Hexadecenyl-2-palmitoyl-d<sub>9</sub>-sn-glycero-3-PE is supplied as a crystalline solid. A stock solution may be made by dissolving the 1-1(Z)-hexadecenyl-2-palmitoyl-d<sub>9</sub>-sn-glycero-3-PE in the solvent of choice, which should be purged with an inert gas. 1-1(Z)-Hexadecenyl-2-palmitoyl-d<sub>9</sub>-sn-glycero-3-PE is soluble in the organic solvent DMSO at a concentration of approximately 3 mg/ml.

### Description

1-1(Z)-Hexadecenyl-2-palmitoyl-sn-glycero-3-PE is a plasmalogen that contains 1(Z)-hexadecanoic acid and palmitic acid (Item No. 10006627) at the sn-1 and sn-2 positions, respectively.
