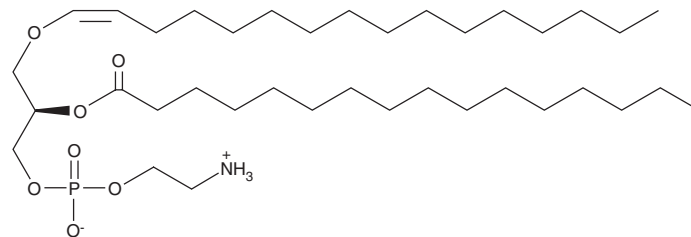

Laboratory Procedures

1-1(Z)-Hexadecenyl-2-palmitoyl-*sn*-glycero-3-PE is supplied as a crystalline solid. A stock solution may be made by dissolving the 1-1(Z)-hexadecenyl-2-palmitoyl-*sn*-glycero-3-PE in the solvent of choice, which should be purged with an inert gas. 1-1(Z)-hexadecenyl-2-palmitoyl-*sn*-glycero-3-PE is soluble in the organic solvent chloroform at a concentration of approximately 3 mg/ml.

Description

1-1(Z)-Hexadecenyl-2-palmitoyl-*sn*-glycero-3-PE is a plasmalogen that contains 1(Z)-hexadecanoic acid and palmitic acid (Item No. 10006627) at the *sn*-1 and *sn*-2 positions, respectively.
