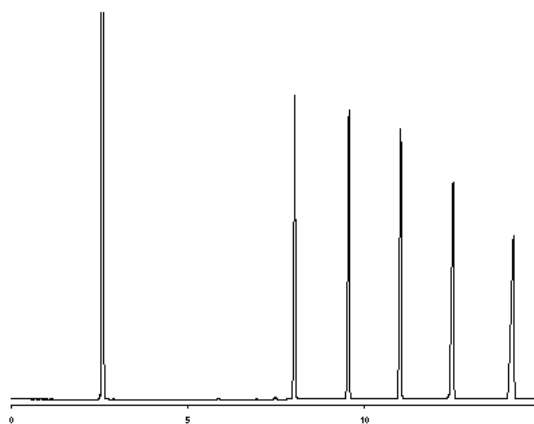
Description and Data
