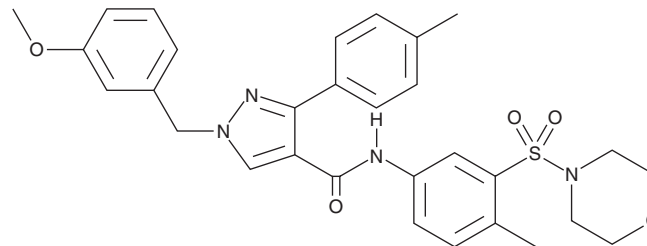

Laboratory Procedures

DY 268 is supplied as a solid. A stock solution may be made by dissolving the DY 268 in the solvent of choice, which should be purged with an inert gas. DY 268 is soluble in organic solvents such as DMSO.

Description

DY 268 is a farnesoid X receptor (FXR) antagonist (IC₅₀ = 7.5 nM in a time-resolved FRET assay).¹ It inhibits FXR transactivation in a cell-based assay with an IC₅₀ value of 468 nM.
