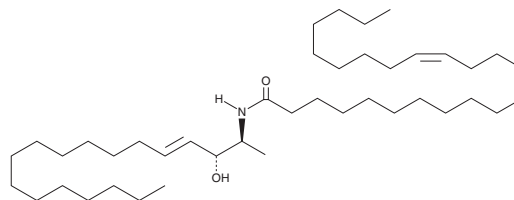

### Laboratory Procedures

C24:1 1-Deoxyceramide (m18:1/24:1(15Z)) is supplied as a crystalline solid. A stock solution may be made by dissolving the C24:1 1-deoxyceramide (m18:1/24:1(15Z)) in the solvent of choice, which should be purged with an inert gas. C24:1 1-Deoxyceramide (m18:1/24:1(15Z)) is soluble in organic solvents such as ethanol, DMSO, and dimethyl formamide (DMF). The solubility of C24:1 1-deoxyceramide (m18:1/24:1(15Z)) in ethanol is approximately 30 mg/ml and approximately 20 mg/ml in DMSO and DMF.

C24:1 1-Deoxyceramide (m18:1/24:1(15Z)) is sparingly soluble in aqueous buffers. For maximum solubility in aqueous buffers, C24:1 1-deoxyceramide (m18:1/24:1(15Z)) should first be dissolved in ethanol and then diluted with the aqueous buffer of choice. C24:1 1-Deoxyceramide (m18:1/24:1(15Z)) has a solubility of approximately 0.5 mg/ml in a 1:1 solution of ethanol:PBS (pH 7.2) using this method. We do not recommend storing the aqueous solution for more than one day.

### Description

C24:1 1-Deoxyceramide (m18:1/24:1(15Z)) is a very long-chain atypical ceramide containing a 1-deoxysphingosine (m18:1(4E)) (Item No. 24687) backbone. 1-Deoxysphingolipids are formed when serine palmitoyltransferase condenses palmitoyl-CoA with alanine instead of serine during sphingolipid synthesis.<sup>1,2</sup>
